A board resolution (bank employees will often call it "BR") is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a bank account in addition to other documents.

How To Draft A Board Resolution To Open A Bank Account ...

A board resolution template is pretty simple. You have to make sure that a specific issue or point that needs a decision is presented to the board so they can address it. A board resolution sample will include places to insert the date, time and location of the meeting. This is found at the top of the page.

If they take a decision in a directors' meeting, this is known as a 'board resolution'. If they take a decision by written resolution, this is sometimes called a 'directors' written resolution', although in practice this is often also referred to as a board resolution. The authorised signatories shall sign on the cheque. Copy of the resolution signed by the president of the association and countersigned by Hon. Secretary or some other office bearers.
